What Students and Parents Need to Know

What options lead to a standard diploma?

Successful completion of one of the following options:

- 24 credits
- Advanced International Certificate of Education (AICE) curriculum
- International Baccalaureate (IB) curriculum
- 18-credit Academically Challenging Curriculum to Enhance Learning (ACCEL)
- Career and Technical Education (CTE) Pathway (See section [s.] <u>1003.4282</u>, Florida Statutes [F.S.])

What are the state assessment requirements?

Students must pass the following statewide assessments:

- Grade 10 English Language Arts (ELA) or a concordant score
- Algebra 1 end-of-course (EOC) or a comparative score

A waiver of assessment results is granted by the Individual Educational Plan (IEP) team for students with disabilities. Additionally, students who have been enrolled in an English for Speakers of Other Languages (ESOL) program for less than two years may meet the requirement for grade 10 ELA by satisfactorily demonstrating grade level expectations of formative assessments.

Refer to <u>Graduation Requirements for Florida's Statewide Assessments</u> for concordant and comparative scores.

Students enrolled in the following courses must participate in the corresponding EOC assessment, which constitutes 30 percent of the final course grade⁺:

- Algebra 1
 Geometry
- Biology
 U.S. History

⁺Special note: Thirty percent not applicable if not enrolled in the course but passed the EOC (Credit Acceleration Program [CAP]). (See s. <u>1008.22</u>, F.S.)

What is the difference between the 18-credit ACCEL option and the 24-credit option?

- 2.5 elective credits instead of 7.5
- Physical Education is not required

What is the difference between the CTE Pathway option and the 24-credit option?

- At least 18 credits are required
- 3.5 elective credits instead of 7.5
 - 2 credits in CTE courses, must result in a program completion and industry certification
 - 1.5 credits in work-based learning programs; Physical Education is not required
- Fine and Performing Arts, Speech and Debate, CTE or Practical Arts is not required

Students must earn a 2.0 unweighted grade-point average (GPA) on a 4.0 scale for all cohort years and pass statewide, standardized assessments.

Scholar Diploma Designation

In addition to the requirements of s. <u>1003.4282</u>, F.S., a student must satisfy the following requirements:

- Earn 1 credit in Algebra 2 or an equally rigorous course
- Pass the Geometry EOC
- Earn 1 credit in Statistics or an equally rigorous mathematics course
- Pass the Biology 1 EOC++
- Earn 1 credit in Chemistry or Physics
- Earn 1 credit in a course equally rigorous to Chemistry or Physics
- Pass the U.S. History EOC++
- Earn 2 credits in the same World Language
- Earn at least 1 credit in an AP, IB, AICE or a dual enrollment course **Special note: A student is exempt from the Biology 1 or U.S. History EOC assessment if the student is enrolled in an AP, IB, or AICE Biology 1 or U.S. History course; takes the respective AP, IB or AICE assessment; and earns the minimum college credit.

Industry Scholar Diploma Designation

- Meet standard high school diploma requirements
- Attain one or more industry certifications from the list established (per s. 1003.492, F.S.)

What is CAP?

Biology

The CAP allows a student to earn high school credit if the student passes an AP examination, a College Level Examination Program (CLEP) or a statewide course assessment without enrollment in the course. The courses include:

- Algebra 1
 Geometry
 - U.S. History

What are the additional graduation options for students with disabilities?

Students, in collaboration with parents and the IEP team, may choose two additional standard diploma options available only to students with disabilities. Both allow students to substitute a CTE course with related content for one credit in ELA 4, mathematics, science and social studies (excluding Algebra 1, Geometry, Biology 1 and U.S. History). The two options are as follows:

- Students with a most significant cognitive disability may earn credits via access courses and be assessed via an alternate assessment.
- Students enrolled in the academic and employment option must earn at least 0.5 credit via paid employment in addition to meeting the standard diploma graduation requirements.

State University System

Admission into Florida's <u>State University System</u> (SUS) institutions is competitive. Prospective students should complete a rigorous course of study in high school and apply to more than one university to increase their chance for acceptance. To qualify to enter one of Florida's public universities, a first-time-in-college student must meet the following minimum requirements (credit earned by industry certification does not count for SUS admission):

- High school graduation with a standard diploma, a minimum of a 2.5 GPA and admission test scores meeting minimum college-ready test scores per Board of Governors (BOG) Regulation 6.008
- 16 credits of approved college preparatory academic courses per BOG Regulation 6.002
- 4 English (3 with substantial writing)
- 4 Mathematics (Algebra 1 level and higher)
- 3 Natural Science (2 with substantial lab)
- 3 Social Science
- 2 World Language (sequential, in the same language or other equivalents)
- 2 approved electives

Florida College System

The 28 colleges of the <u>Florida College System</u> serve more than 650,000 students. Colleges offer affordable and stackable workforce credentials including certificate programs, associate in science degrees and associate in arts degrees, which transfer to a bachelor's degree program. All colleges also offer workforce bachelor's degree programs in areas of high demand. All Florida College System institutions have open-door admissions for students who earned a standard high school diploma or an equivalent diploma, or earned college credit.

Career and Technical Colleges and Centers

Florida also offers students 49 accredited career and technical colleges or centers throughout the state, which provide the education and certification necessary to work in a particular career or technical field. Programs are flexible for students and provide industry-specific education and training for a wide variety of occupations.



INITIAL ELIGIBILITY REQUIREMENTS: As determined by the Florida Department of Education

Submit the Florida Financial Aid Application (FFAA) no later than August 31 after high school graduation.

Graduate from a Florida high school with a standard high school diploma or its equivalent.

Complete the 16 college-preparatory courses required for admission to a state university.

Achieve the required weighted GPA in the 16 college-preparatory courses per the chart below.

Achieve the required composite ACT® score, Overall Score on the Classic Learning Test (CLT), or combined SAT® score no later than August 31 of the student's graduation year (or through January 31 for mid-year graduates), per the chart below.

Complete the required number of volunteer service hours, paid work hours, or 100 total combined hours per chart below.

REQUIREMENTS TO RECEIVE AN AWARD:

1. Be evaluated by the Office of Student Financial Assistance (OSFA) as meeting initial eligibility requirements.

2. Be a Florida resident and U.S. citizen or eligible noncitizen.

3. Enroll as a degree- or certificateseeking student at a Florida institution in at least 6 non-remedial semester credit hours.

SCHOLARSHIP RESTRICTIONS

Until a student has earned an eligible associate degree, Gold Seal CAPE (GSC) scholarships may only be used at postsecondary institutions that offer an applied technology diploma, technical degree education program (associate in applied science or associate in science), or a career certificate program.

Upon completion of an eligible associate degree program, a GSC Scholar may also receive an award for a maximum of 60 credit hours toward an eligible baccalaureate degree.

Academic Requirements

Division I and II schools require you to meet academic standards. To be eligible to practice, compete and receive an athletics scholarship in your first year of full-time enrollment, you must meet the following requirements:

Division I


1. Earn 16 NCAA-approved core-course credits in the following areas:



- 2. Complete your 16 NCAA-approved core-course credits in eight academic semesters or four consecutive academic years from the start of ninth grade. If you graduate from high school early, you still must meet core-course requirements.
- 3. Complete 10 of your 16 NCAA-approved core-course credits, including seven in English, math or science, before the start of your seventh semester. Once you begin your seventh semester, any course needed to meet the 10/7 requirement cannot be replaced or repeated.
- 4. Earn a minimum 2.3 core-course GPA.
- 5. Ask your high school counselor to upload your **final official transcript** with proof of graduation to your Eligibility Center account.

Division II

1. Earn 16 NCAA-approved core-course credits in the following areas:



- 2. Earn a minimum 2.2 core-course GPA.
- 3. Ask your high school counselor to upload your **final official transcript** with proof of graduation to your Eligibility Center account.

Division III

While **Division III schools** set their own admissions and academic requirements, **international student-athletes** (first-year enrollees and transfers) who are enrolling at a Division III school after Aug. 1, 2023, must be certified as an amateur by the Eligibility Center. Contact the Division III school you plan to attend for more information about its academic requirements.

CELL PHONE POLICY

Cell phones must be out of sight during class time. If a cell phone is being used to text, talk, access social media, listen to music or check the time during class time, the student will be given a warning on the first offense. On the second offense, the teacher has the option of taking the cell phone and returning it at the end of the period. Any additional offenses will result in a referral. This procedure applies to ALL ELECTRONIC devices. BCHS is NOT responsible for lost, damaged, or stolen cell phones or other electronic devices. These situations should be reported to the School Resource Officer.

NO DELIVERIES POLICY

Students will not be permitted to receive deliveries of food, flowers, or other items during the school day. No exceptions!

PARKING PERMITS REQUIRED

All students who drive to school and park on campus will be required to purchase a parking pass. Cost is \$20.00. Valid driver's license and proof of insurance and registration are required.

ATTENDANCE POLICY

Attendance is taken in every class and counts towards course credit period by period. Each semester (Aug to Dec, and Jan to May), students whose unexcused absences exceed 9 days will not receive credit for that class or classes. Notes from parents or guardians **will not** be accepted to excuse students' absences. Students having credit withheld will be referred to the School Attendance Review Board, and can be referred to Truancy Court.

TARDIES TO SCHOOL

Students are expected to arrive at school on time. Students arriving late must sign in at the Front Gate and receive a late pass in order to be admitted to class. On the 4th tardy to school, students will be referred to administration for lunch detention. On the 8th tardy to school, students will serve additional days of lunch detention. After 10 tardies, students will receive a referral and be assigned to a day of in school suspension.

TARDIES BETWEEN CLASSES

Students who have not crossed the threshold of their classroom when the 3rd bell rings, will be considered tardy. On the 4th tardy to class, students will be referred to administration for lunch detention. If students are referred a second time within the same nine week grading period, they will be assigned a full day of in school suspension. If students are more than 10 minutes late to class and do not have an excuse note, they will be considered to be skipping and will be referred to administration.

DRESS CODE

The Baker County School District's dress code is an attempt to create a positive environment for the education of our youth. Students are expected to come to school in a neat, clean fashion and are to wear shoes at all times. Students are prohibited from wearing clothing that exposes underwear or body parts in an indecent or vulgar manner or that disrupts the orderly learning environment.
