- **Recognition of "Gold Status" as a Florida Healthy School District** (*Presentation by Florida Action for Healthy Kids and Florida Coordinated School Health Partnership* )\*

Carol Vickers, Chair of the Florida Coordinated School Health Partnership, presented Superintendent Raulerson with the “Gold Status” Florida Healthy School District flag. This designation is sponsored by the Florida Association of District School Superintendents, Florida Action for Healthy Kids and Florida Coordinated School Health Partnership. Baker County School District was over 90% in the qualification criteria and received the highest score in the State of Florida in Health Services. Superintendent Raulerson recognized Tina Bradley, School Health Services Specialist, and the individual registered nurses at each school site: Jamie Yonn, Pre-K/Kindergarten Center, Cheryl Kennedy, Macclenny Elementary School, Lana Bliss, Baker County Middle School, Jana Crews and Shanna Jones, Keller Intermediate School, Laura Raulerson, Baker County High School, and Vonda Crews, Westside Elementary School. Superintendent Raulerson also recognized Debbie Gnann, teacher of the Health Academy at Baker County High School. There have been several nurses and doctors who Ms. Gnann had the opportunity to teach many students through the Health Academy. Several of the students who successfully completed the Health Academy have gone on to college and become nurses and doctors.
