▶ Recognition of Contributions of Baker County Friends of Instrumental Artists

Superintendent Raulerson presented an appreciation plaque to the Baker County Friends of Instrumental Arts (BCFIA) in honor of their hard work and dedication to the students of Baker County Public Schools who have a desire to learn to play musical instruments. The BCFIA was incorporated as a non-profit organization on January 16, 2009, to create an avenue for providing financial support to instrumental arts programs. The BCFIA engages in fund raising activities that assist in offering opportunities for students to get involved and stay involved in music. They provide funding to aspiring musicians through college scholarships and the chance to obtain volunteer hours for BCHS students. Through the years, BCFIA has raised a grand total of \$20,680.00 to support the Baker County Public School music programs.

Superintendent Raulerson shared that, most recently, the BCFIA donated several African drum sets to Westside Elementary School and they were really being enjoyed by the students. Also, noted was several of the upcoming fundraiser events including hosting a booth at the annual Macclenny Christmas Parade event and Breakfast with Santa in which all of the funds raised at the events will go directly to the students.

> Recognition of Everett Allen Murphy's Completion of the Principal Leadership Academy for School Principal Certification

Mr. Allen Murphy was presented with a Certificate of Completion plaque by Mr. Mark Bracewell, Program Development and Training Specialist for School Leadership from The North East Florida Educational Consortium (NEFEC). The Principal Leadership Academy for School Principal Certification is a 15 month extensive, demanding, rigorous, and high quality program facilitated by Mr. Bracewell at NEFEC.
